Part A: Pupil premium strategy plan

Statement of intent

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress, achieve high attainment across all subject areas and experience a range of enriched activities. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

Common barriers to learning for disadvantaged pupils can include weak language and communication skills, lack of confidence, attendance and punctuality issues and more frequent behaviour issues. There may be complex situations that prevent children from flourishing. We recognise that the challenges are varied and there is no 'one size fits all'. As recognised by the EEF we acknowledge that 'good teaching is the most important lever' schools have to improve outcomes for disadvantaged pupils.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- Promote an ethos of attainment for all, with no child left behind.
- Individualised approaches to address barriers.
- Ensure disadvantaged pupils are challenged in the work that they're set.
- Act early to intervene at the point need is identified.
- Adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve.

Whilst our strategy adopts the recommended EEF tiered approach, we recognise that many elements of the strategy will overlap categories and that the balance of the approach will vary from year to year as the schools' and pupils' priorities change.

Challenges

Improved oral language skills and vocabulary among disadvantaged pupils.	Assessments and observations indicate significantly improved oral language among disadvantaged pupils. Assessments to identify oral language needs will include; Wellcomm (ages 4 – 7), Nuffield Early Language Intervention (NELI) and Language for Thinking (ages 7 – 11). These assessments will be triangulated with other sources of evidence, including engagement in lessons, book scrutiny and ongoing formative assessment.
Disadvantaged pupils' progress improves in all year groups, in reading, writing and maths.	Progress data particularly for Year 6 shows a narrower/narrowing gap. The difference between disadvantaged KS2 pupils' attainment is comparable to non-disadvantaged pupils.

This details the impact that our pupil premium activity had on pupils in the 2023 to 2024 academic year.

Improved oral language skills and vocabulary among disadvantaged pupils.	Pupils are accessing tier 3 vocabulary and using this across lessons; pre-teach of vocabulary across lessons and subjects is in place to reduce the gap.
Improved writing attainment for disadvantaged pupils at the end of KS2.	50% of disadvantaged pupils finished Year 5 working at or above age-related expectations. Last academic year we had no Year 6 pupils so end of KS2 data is not available.
Improved reading attainment among disadvantaged pupils.	65% of disadvantaged pupils finished Year 5 working at or above age-related expectations. Last academic year we had no Year 6 pupils so end of KS2 data is not available.
Improved maths attainment for disadvantaged pupils at the end of KS2.	70% of disadvantaged pupils finished Year 5 working at or above age-related expectations. Last academic year we had no Year 6 pupils so end of KS2 data is not available.

How did you spend your service pupil premium allocation last academic year?	We hired two Learning Mentors who provide support for the emotional wellbeing and academic achievement of service children. The pupils have access to 'The Den' or 'The Rainbow Room', our pastoral rooms for either one to one sessions or group nurture sessions.
What was the impact of that spending on service pupil premium eligible pupils?	Teachers observed improvements in wellbeing and attention amongst service children. Informative assessments demonstrated progress in subject areas where extra support classes were provided.
